1) Board Members Report

A. The WaterStarters Foundation

WaterStarters (WS) is registered in the Netherlands as a foundation that is established with the intention



to provide clean and safe drinking water to people in developing countries. The foundation aims to raise money through investors, donations, crowdfunding, loyalty programs and more to ensure that the commitment to bring clean drinking water to people is achieved through the implementation of social entreprises for water projects and other social developments in communities. The WaterStarters' vision and mission is 'Better health in Kenya by setting up a renewed method for sustainable water solutions in combination with health and education for the rural and peri-urban communities'. WaterStarters considers the social-cultural aspects of the people, the environment, and the economic requirements as core values.

B. MegaGroup

MegaGroup is a Dutch technical wholesale company that believes in making water solutions accessible to improve the lives of people. With a mission to enabling sustainable growth to different stakeholders like customers, employees and shareholders by making water solutions



available in a smart, convenient, and efficient manner. The goal is to become the number one partner and the best alternative in the market. MegaGroup is committed to contributing towards major water threats globally through irrigation, livestock and industrial applications.

C. Amref Flying Doctors

Amref Flying Doctors (Amref NL) in the Netherlands is a nonprofit entity affiliated with Amref Health Africa (active since 1957), Africa's biggest nonprofit health organisation with 11 African country offices working on a wide range of topics related to health. Amref NL's corporate strategy focuses on strategic partnerships, resource mobilisation and innovative fundraising



in its commitment to empowering African leadership, ensuring locally driven and culturally sensitive initiatives while leveraging on years of experience in developing commercially viable programmes for lasting change. By fostering collaboration and investing in healthcare infrastructure and personnel, Amref NL facilitates lasting health improvements, with a focus on marginalised groups, especially youth and women.

D. Organisation

The WaterStarters organization is built up of a mix of volunteers and employed people. In total, ca. 18 people are active in and/or for the WaterStarters organisation representing ca. 7 FTE's.

E. The challenges

To date, two out of five people in Kenya do not have access to safe water sources. In rural areas, more than half of the population obtains water from unsafe surface sources such as lakes, rivers and ponds. This leads to enormous negative long-term effects on economic development. Especially for people living in rural and peri-urban communities, where the situation is worse.

F. Our ambition

Our belief is that every human being should have access to safe and affordable drinking- and household water and that no one should suffer from waterborne diseases. We want to radically improve this situation for 1.5 million Kenyans in water-stressed areas in the coming seven years with a total investment budget of € 30 million.

G. The partnership

The partnership between MegaGroup and Amref was initiated to address water related issues facing people in communities in Kenya. MegaGroup's expertise in water solutions and Amref's community-led health promotion resulted to the introduction of WaterStarters; a franchise that will manage the renovation and/or building of 600 water supply schemes to positively impact the economic and health situation in rural and peri-urban communities in Kenya. Fundamental cornerstones of the WaterStarters model are community co-investment and the sale of water, reflecting its value as a scarce resource.

This collaboration offers an opportunity and a platform for different stakeholders such as impact investors, donors, and commercial corporate organisations to strategically raise funds for developments in water and sustainable finance. It is intended to supply and distribute water according to local needs like provision of clean water for drinking in households, water for livestock or water for domestic use. Hence the water infrastructure is designed according to the identified community needs and considering the special need groups like those who are physically disabled/challenged.

H. Ways of raising funds

MegaGroup and Amref have specific network options to raise funds for WaterStarters based on the capabilities and expertise of each party. There are several ways for raising funds:

- Amref Flying Doctors has a large base of private donors, family foundations, corporate partners, as well as prospect partners to attract donations and investments.
- Through MegaGroup's loyalty program named Waterpoints, the WaterStarters Foundation can count on a yearly contribution. This as part of MegaGroup's customers donate their accumulated points to the WaterStarters initiative.
- MegaGroup has pledged to donate 1% of their recurring EBITDA to the Foundation on annual basis.
- When scaling, MegaGroup will engage their customers and suppliers to donate or contribute water supply resources and possibly materials to WaterStarters, increasing the pool of resources.
- WaterStarters has developed a website where projects will be uploaded with detailed project-specific reports. Transparency on investments and real-time performance through a monitoring dashboard will allow for the public and impact investors to directly invest in water and health.
- We will further investigate the option of results-based financing. This is an approach involving a funder that is willing to make payments to a broker that has presumed to achieve pre-defined results. Hence the funding is only earned after the achievement of the results. The logic behind this approach is to channel financing more directly with outputs and outcomes. This method aims to increase accountability and create incentives to improve the programme's effectiveness. This method can be approached in two ways; through commercial funding and donations.

I. Achievements

- 1. A first agreement between MegaGroup and Amref Flying Doctors was signed in 2019, which was amended into a teaming agreement in 2020. In 2021, a Consortium Agreement was drafted and signed between the Stichting WaterStarters, MegaGroup, Amref Flying Doctors and Amref Health Africa (Kenya). The goal of this agreement is to pilot the WaterStarters model to provide secure, more sustainable and affordable water and health services in peri-urban and rural areas in Kenya, by improving the management of existing and new boreholes, in combination with a health education and promotion program.
- 2. The pilot phase of the project was budgeted at € 395,000. MegaGroup and Amref believe that each partner should be equally invested and risks need to be shared. Therefore, they have both

committed to € 75,000 seed funding, totalling € 150,000.

The initial duration of the project set at 18 months, but this timeline was extended to June 30th, 2024.

- 3. Over and above the above seed money, WaterStarters Foundation was successful in applying for financing to cover for the remaining pilot budget:
 - a. Aqua for All acts as a co-developer of the program and contributes € 75.000.
 - b. Invest International (formerly known as FMO) acts as the financial co-developer of the program and contributes € 162,500, of which 25% only must be refunded upon a successful pilot project.
 In December if 2023, Invest International informed
 WaterStarters that the 25% payback had been converted to a gift.

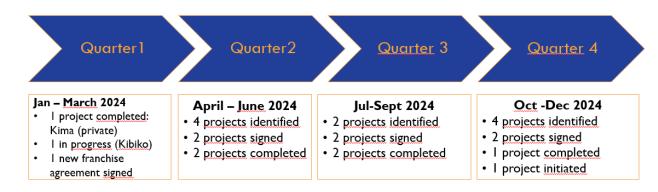

4. Following the successful start of the pilot projects as mentioned above, WaterStarters has been successful in applying for a grant from Danida Green Business Partnerships (DGBP), for a Maturation Project grant. This program is funded under the Danish development cooperation. DGBP supports innovative projects in 32 developing countries aimed at creating new market-based solutions to climate and environmental challenges while contributing to economic growth, job creation, and improved livelihoods. SDGs 1, 8, 12, 13, and 17 are at the heart of the DGBP program.

J. Looking ahead to 2024

Financing has been secured to extend the WaterStarters pilot and add two communities. At the end of 2023, the term for the pilot project for the three communities has planned to be extended to 31-1-2025, including additional funding from Aqua for All.

Below is the working plan for 2024, focusing on onboarding the two additional communities, but also getting a better picture of the first three communities, i.e. is the model working, can the Franchisees come up with the upfront 15% investment, can the sell water and repay the loans.

4) Accounting policies

General

The financial statements have been prepared in accordance with the guideline for fundraising institutions as issued by the Dutch Accounting Standard Board (guideline 650).

In the balance sheet and income statement references are included. These references refer to the notes.

Going concern

The present accounting policies of valuation and determination of result used are based on the assumption of going concern of the Foundation.

Changes in accounting policies/Estimates

During the year no changes in accounting policies or estimates occurred.

A. Accounting policies for the balance sheet

General

In general assets and liabilities are stated at the amount at which they were acquired or incurred. If not specifically stated otherwise, they are recognised at the amounts at which they were acquired or incurred. The balance sheet and income statement include references to the notes.

Cash and cash equivalents

Cash and cash equivalents are stated at face value.

Reserves

The amount of reserves shows the difference between the assets and the liabilities. This amount is at free disposal of the Board, but must be used to achieve the objectives of the Foundation.

B. Accounting principles for the income statement

General

Profit or loss is determined as the difference between the revenues and the expenses for the year. Revenues and expenses are recognised in the year in which they are realised. This calculation follows a consistent course of action. This means that the expenses take into account the amounts attributable to a period that have been paid in another period.

Revenues

All revenues are recognised at their gross amount in the revenues.

Expenses

Expenses are determined on a historical base and allocated to the reporting year to which they related.

C. Notes to the balance sheet

The other receivables consist of the annual donation by MegaGroup netted against prepaid expenses.
